## **COMMON SCAMS TO AVOID**

Every year, thousands of people in the U.S. fall victim to fraud. Seniors are usually a large target for these scammers. Knowing how to spot fraud starts with being able to identify some of the most common scams.

- **Government Impersonation:** The scammer will contact you over the phone and say that they are a member of a government agency or law enforcement, calling about a situation. They may tell you that a car you have registered was found at a crime scene, and you may be arrested if you don't comply.
- **Romance Scams:** Scammers will try to take advantage of people looking for love using online dating websites or social media. The scammer will create a fake persona, gain your trust, and then ask for money to fix a car or to make ends meet for the month.
- Grandparent Scams: In an attempt to tug on heartstrings, the scammers may call over
  the phone pretending to be a family member or a law enforcement officer claiming that a
  grandchild is in trouble. The scammer will claim that they need money wired as soon as
  possible.

Mistakes happen, and if you're worried you or someone you love is a target of fraud, you should contact your financial institution immediately. Taking steps to report fraud early minimizes the damage that these fraudsters have created.

The Nominating Committee must receive a letter of nomination no later than Friday, July 15, 2022. Nomination letters may be sent to 8818 Garland Road, Dallas, Texas 75218, Attn: Nominating Committee.

Nominees will be mailed a Director Application and Agreement to Serve by Monday, July 18, 2022 that must be completed and returned to the Nominating Committee by Monday, August 1, 2022. The Nominating Committee will make their recommendations to the Board of Directors at the August regular board meeting.

Any Nominee not selected by the Nominating Committee may petition to run for the Board of Directors and will be mailed a petition package containing specific instructions and documents required to complete the petition process by Wednesday, October 26, 2022. A list of confirmed nominees for these Board positions will be posted in the lobby and included in the winter newsletter.
